The application must be submitted no later than 4:30 p.m. to the Battlefield City Hall, 15 working days prior to the Planning and Zoning Commission meeting at which the final development plan will be considered. Contact the City Clerk at the telephone number below for filing deadlines and meeting dates.

<b>APPLICATION FORM:</b>	
	Indicate if the final development plan is for a residential planned development or a mixed use planned development.
	List date of Preliminary Development Plan approval by Board of Aldermen.
	List date of Preliminary Plat approval by Board of Aldermen.
	Indicate development name.
	Provide a street address or other general property description for the planned development.
	Provide the legal description of the property to be rezoned. You may attach the legal description on a separate sheet.
	List the current property owner's name, address, and telephone number. If a corporation, list the corporate official and include the corporate seal.
<b>APPLICATION FEE:</b>	
	None. Application fee is included in the preliminary development plan application fee.
<b>FINAL DEVELOPMENT PLAN:</b>	
	Submit ten copies of a final development plan for the proposed planned development. See Section 5.9 of the <i>Battlefield Zoning Regulations</i> for details on Planned Developments. The final development plan is to include the following information:
	1. Site plan in conformance with the requirements of Article III, <i>Battlefield Zoning Regulations</i> .
	2. Preliminary building plans, including floor plans and exterior elevations.
	3. Landscaping plans in accordance with Article VIII, <i>Battlefield Zoning Regulations</i> .
	4. Copies of any easements and restrictive covenants.
	5. Proof of the establishment and activation of any entity that is to be responsible for the management and maintenance of any common open space or facilities.
	6. Evidence that no lots, parcels, tracts or dwelling units in such development have been conveyed or leased prior to the recording of any restrictive covenants applicable to the planned development.
<b>FINAL PLAT:</b>	
	If applicable, submit final plat concurrently with the final development plan. See <i>Battlefield Subdivision Regulations</i> for final plat requirements.
<b>ENGINEERING REVIEW FEE:</b>	
	Submit engineering review deposit fee of \$500. If engineering review costs are greater, City will bill applicant for additional costs.
