The application must be submitted no later than 4:30 p.m. to the Battlefield City Hall, 15 working days prior to the Planning and Zoning Commission meeting at which the sketch plan will be considered. Contact the City Clerk at the telephone number below for filing deadlines and meeting dates.

<b>PRE-APPLICATION CONFERENCE:</b>	
	Although not required, the applicant is encouraged to discuss the proposed subdivision with City staff prior to submitting the sketch plan. City staff may inform the applicant of any particular concerns that should be addressed in the sketch plan.
<b>APPLICATION FORM:</b>

	Indicate if proposed subdivision is a conservation subdivision.

	Submit nine (9) copies of a sketch plan containing the following information. The sketch plan is to be drawn to an approximate scale of 1" = 100'.
	A. Name and address of the property owner/developer.
	B. Tract boundaries and principle features within 1000 feet
	C. Proposed subdivision name and location by lot, section, township, range.
	D. Approximate north arrow and scale.
	E. Approximate total acreage of the subdivision.
	F. Existing streets on and adjacent to the tract, including width of rights-of-way.
	G. The tentative street and lot arrangement.
	H. Existing utilities.
	I. Existing drainage ways.
	J. Approximately location, dimensions and configuration of all proposed or existing lots.
	K. Unique topographical and physical features.
	L. Any proposed parks, school sites or any other community facilities.
<b>Note: The Planning and Zoning Commission shall not take action on the sketch plan when the applicant or the applicant's agent does not appear at the Commission meeting to provide evidence regarding the sketch plan for the proposed subdivision.</b>
