**CHECKLIST  
ZONING APPEAL  
City of Battlefield, Missouri**

This checklist is provided to help you make sure that you submit everything that is required for a complete zoning appeal application. This application must be complete and all items listed on the attached application checklist must accompany the application before the application will be forwarded to the Board of Adjustment. The application must be submitted within 30 days after the date of the decision that is being appealed. Applications are to be submitted no later than 4:30 p.m. to the Battlefield City Hall. Please contact the City Clerk at the telephone number below for public hearing date before the Board of Adjustment.

<b>APPLICATION FORM:</b>	
	Include the legal description of the land involved in the appeal request. Attach the legal description on a separate sheet if necessary.
	List the street address or other common description of the land or property involved.
	Indicate the name of the Administrative Official who made the decision that you are appealing.
	List the date of the decision that you are appealing.
	Describe the decision or order that you believe the Administrative Official made in error. It is the applicant's responsibility to produce evidence establishing the grounds for the appeal.
	Describe the nature of the decision that you are requesting from the Board of Adjustment.
	List the current property owner's name, address, and telephone number. If a corporation, list the corporate official and include the corporate seal.
	Property owner, or if applicable, a corporate official must sign the application.
	If the applicant is different than the property owner, list the applicant's name, address and telephone number. The applicant must sign the application.
<b>PROPERTY OWNERS NOTIFICATION:</b>	
	Submit a list of property owners' names and addresses within 185 feet of the property involved in the appeal which has been prepared by a title company authorized to issue title policies in the State of Missouri.
	Submit an addressed and stamped (not metered) business envelope for every property owner listed on the property owners' list.
<b>APPLICATION FEE:</b>	
	Include the \$75.00 application fee. Applicant also responsible for advertising and notifications for public hearing. City will bill applicant for public notification costs.
<b>Note: The Board of Adjustment shall not take final action on any case when the applicant or the applicant's agent does not appear at the public hearing before the Board to provide evidence regarding the applicant's appeal.</b>
